When you are ready to send your hired items back or have them collected by us please contact us on 0800 093 1202 (Option 1) to arrange collection.

An RMA number will be allocated and you will be asked to apply a label to the product in its original packaging and an agreed date for collection will be confirmed. It's imperative the product is available for collection to avoid further hire charges being incurred.

Terms and Conditions of Hire

1. Definitions

Mayflex UK Ltd shall hereinafter be referred to as the **Owner**. A Company hiring equipment shall hereinafter be referred to as the **Hirer**. Items hired shall hereinafter be referred to as **The Equipment**.

2. Contract Charges

The minimum hire contract period shall be based on a seven-day week inclusive. Any period less than seven shall be treated as a complete week for the purposes of invoicing. The charges on each contract shall be at the rates specified within the pricing brochure. Carriage charges in either direction shall be included to the weekly hire rates agreed.

It is important to note that extending your hire for a longer period when you already have the unit on loan will be charged with an additional 25% to the normal weekly hire cost. This is due to the fact that we have to contact and manage customers' expectations who were expecting the unit you had on hire to be returned and subsequently issued to them.

3. Contract Period

The hire contract period shall commence from the date of the delivery or the date of collection from the Owner's premises. The period of hiring shall cease on the day the Equipment is collected from the Hirer's premises or delivered back to the Owner's premises.

4. Hirer's Responsibility

- a) The Hirer will ensure that the Equipment is checked upon receipt for damage or defects and check for any missing items and advise on day of delivery. The Owner shall not be responsible for damage to such goods if not informed on the day of delivery.
- b) Equipment is kept in a good and sound condition during use and storage.
- c) Equipment is not to be subjected to any misuse or unfair wear and tear during use and storage.d) Preserve the Owner's or Manufacturer's identification numbers or marks on the Equipment.
- e) Observe entirely the Owner's or Manufacturer's instructions and other regulations that may be issued for the proper use thereof
- and will be responsible for any damage caused to the Equipment arising from a failure to observe such instructions or regulations.
 f) Indemnify the Owner in respect of any loss or damage, however caused, during use and storage of the Equipment. In the event of such loss or damage the Hirer will immediately inform the Owner. A replacement or repair cost will be quoted including any
- shortfall in income as a result of the loss or damage. The agreed hire charges will continue until the Owner has been reimbursed in full.
- g) Equipment is suitable for use, with particular attention to hazardous environments and use abroad.
- h) Arrange adequate insurance to cover the full replacement cost of the Equipment if used in hazardous environments or for use abroad.
- i) The Hirer shall not, without previous consent of the Owner, use Equipment outside the U.K.
- j) The Hirer shall not, without previous consent of the Owner, sell or offer for sale, pledge, lend or otherwise dispose of or part with possession of the Equipment.

5. Third Party Requirements and Consequential Losses

The Hirer will not hold the Owner responsible for any loss, damage, injury, death to persons, or property for whatever reason with regard to use of Equipment hired. The Owner shall not be liable for any consequential expense, liability, loss, claim or proceedings whatsoever caused by, or arising out of the late delivery, unsuitability, failure or repossession of the Equipment and plant or any part thereof or any breakdown or stoppage of same.
